Miller Lake County Forest Road #7, Crow Wing County , Minnesota



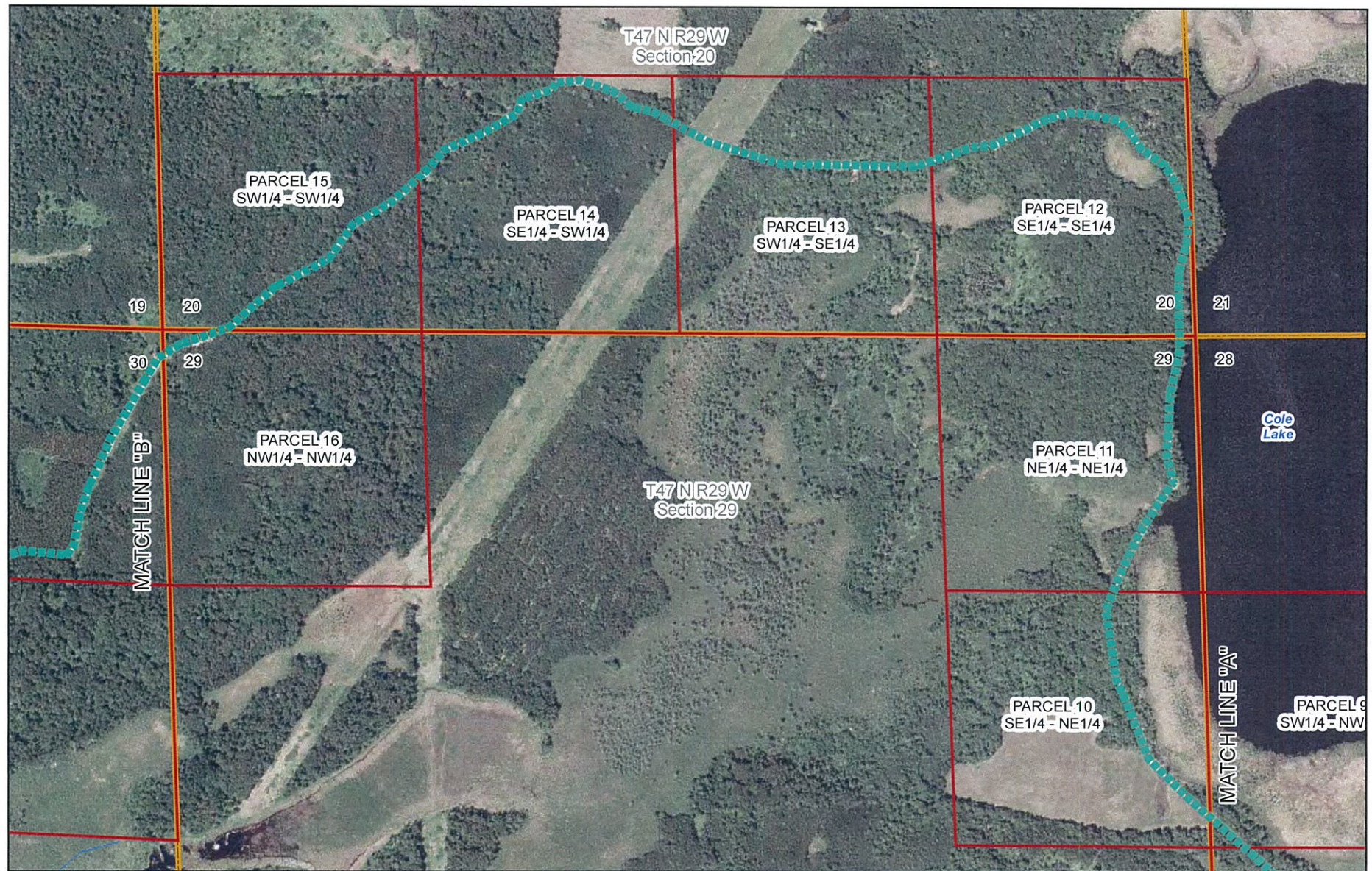

Miller Lake County Forest Road #7, Crow Wing County , Minnesota



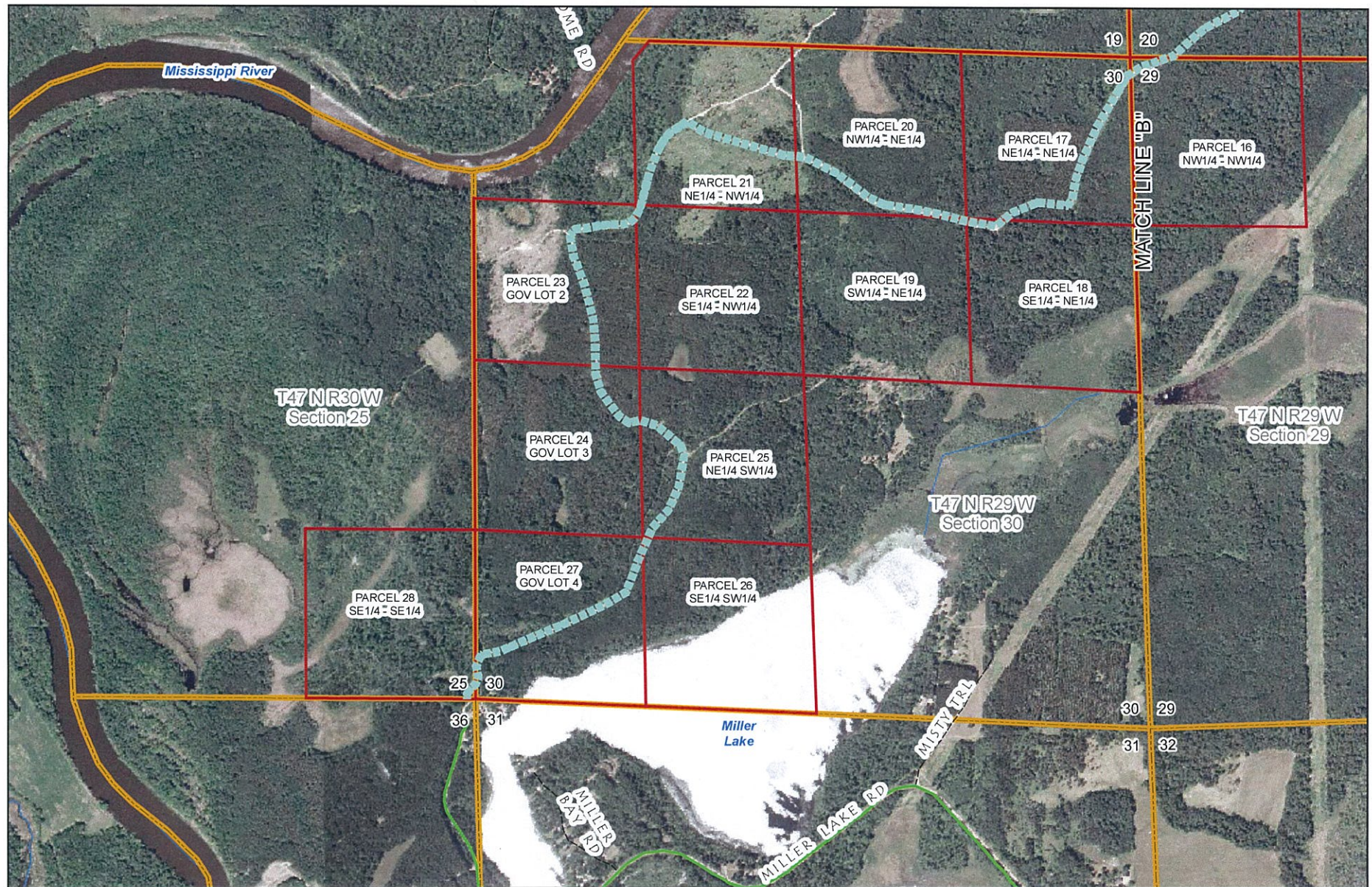
