

## **MINUTES OF REGULAR MEETING OF THE POLICY COMMITTEE PINE RIVER ONE WATERSHED ONE PLAN**

A regular meeting of the Policy Committee (PC) was held at the Ideal Community Center, Ideal Township, MN, and called to order by Chair Jeff Peterson at 12:36 p.m. on May 30, 2018. Noted that a person with a forestry background has not yet been identified from Crow Wing County to serve on the Advisory Committee. Melissa Barrick will provide the Policy Committee members with a list of the Advisory Committee members.

- Melissa Barrick gave a report on the Kick Off open house. Written report provided. Approximately 45 citizens attended the open house. Positive feedback. Comments of attendees will help inform the data as to the public perspective on the 1W1P. Expenditures for the open house were about \$800.
- Melissa Barrick advised that in general statements of expenses will be provided upon completion of each part of the Plan. Following discussion it was agreed that individual bills of vendors/contractors will be provided to the members of the Policy Committee who will have the opportunity to approve/disapprove/comment, and approval of at least three members of the PC will be required to authorize payment.
- Written comments of state agencies stating their priorities were provided: BWSR, MDH, MDNR, MDA, and a brief oral summary of each report was given.
- Melissa Barrick presented the proposed Plan itinerary and meeting schedule.
