
BE IT FURTHER RESOLVED said Improvement District is to have a board of directors consisting of five members.



We the undersigned, representing the record owners of more than (51%) percent of the total land area within the proposed Lake Improvement District (referenced lots of parcels listed below, of land abutting Lower South Long Lake) hereby petition the Crow Wing County Board to create a Lake Improvement District for the necessary purpose on improving water quality of Lower South Long Lake through lake management, aquatic vegetation control and related services to Lower South Long Lake. The proposed Lake Improvement District is legally described as follows:

Named: Lower South Long Lake Improvement District

We propose the district be called: *The Lower South Long Lake Improvement District.* We propose a board consisting of five (5) members elected from residents around the lake. The proposed district would be bounded by the following road boundaries: [See attached map]

Starting at Minnesota State Highway 25 going east on Crow Wing County Road 22 to Crow Wing County Road 23. Going North on County Road 23 to Narrow Lane Road. Going West on Narrow Lane Road to Crow Wing County Road 144. Continue on County Road 144 to where it intersects with Crow Wing County Road 143. Continue on County Road 143 to where it reconnects to Minnesota Highway 25.

Each owner of lands within 1000 feet of Lower South Long Lake will be assessed for one (1) unit. This lake improvement district is for an estimated amount of \$24,000.00 per year, per assessment unit share, for an initial period of 5 years. The lake improvement cost will be equally allocated among all property owners with an estimate of \$80.00 for each property owner with lands within 1000 feet of Lower South Long Lake. Budgets for subsequent years shall be determined during the last year of the assessment and will be subject to public hearing.

We the petitioners understand that the improvement shall be conducted in accordance with plans for the same to be prepared, reviewed and approved by the county board, and that the costs thereof, including expenses connected with engineering, planning and legal costs will be assessed against each parcel of land within said proposed district.
