Commissioner Walters offered the following resolution and moved its adoption:


WHEREAS, the Board of Commissioners of Crow Wing County, Minnesota, acting as the legal entity for the Round Lake Improvement District, and

WHEREAS, the Round Lake Improvement District has recommended an assessment for lake management, aquatic vegetation control and related services to Round Lake totaling \$13,980 per year for five years.

NOW, THEREFORE, BE IT RESOLVED the Board of Commissioners of Crow Wing County, Minnesota:

1. Such proposed service assessment is hereby accepted and shall constitute the service assessment against the lands named therein, and each tract of land therein is hereby found to be benefited by the improvement district in the amount of the assessment levied against it.
2. That the total assessment shall be \$13,980.00 per year for five years and is to be distributed at \$62.13 per year for each property owner with lands immediately adjacent to Round Lake.
3. The County Auditor shall extend this assessment on the proper tax lists of the County, and such assessment shall be collected and paid over in the same manner as other County taxes.

BOARD PROCEEDINGS:

Sugarbush Creek . . . This fall, once the leaves are off the trees, work will be done to complete a survey to establish the elevation at which the beaver dam will be maintained.

Lake Management Plan . . . The Round Lake Improvement Association Lake Management Plan Committee (Bill McGrath, Nancy Baxter, Chuck Burton, Cyril Durrenberger, Scott Fisher and Marie Jorgensen) is in the process of reviewing the final draft of a lake management plan prepared with the help of Ed Feiler, DNR. The final plan will be submitted to the Round Lake Improvement Association Board for consideration of approval at a future meeting. It was suggested that the final plan include initiatives to restore vegetation along the banks of Sugarbush Creek, harvest areas of Horsetail weeds and plant white pines along the lake shoreline to help control weeds.

Informal Public Access off TH 371 . . . Phil Meyers has prepared and will submit a letter to MnDOT regarding the closing of the unofficial public access at the end of Hillcrest Drive east of TH 371.

Miscellaneous . . . Scott Fisher has contacted representatives of the Bay Lake Association and confirmed that they are a 501C-3 non-profit organization similar to the Round Lake Improvement Association. The Bay Lake residents are voluntarily contributing funds for lake improvements by allocating funds to the association through their state tax returns. They are not diverting income tax obligations but are designating potential refunds to the lake improvement fund. . . . Phil Meyers suggested investigating the use of Boy Scout Troops for Round Lake Improvement Association water quality and clean-up initiatives as part of their community service projects . . . Marie Jorgensen will contact an acquaintance on Clark Lake to determine the possibility of, and the cost, to use/rent Clark Lake's weed harvester on Round Lake's Horsetail and other weeds. . . Scott Fisher will check on installing marker buoys to delineate the use of a consistent channel on the Round Lake side entering Bishop's Creek (hopefully keeping the trench hollowed out) . . . next meeting after Jan. 1, 2005.

Round Lake Improvement District

Scott Fisher reports that the required number of signatures was received on the petition. Virtually 100% of the property owners who were contacted with the petition on Labor Day weekend were in favor of forming the district and the application for the improvement district is in process.

Scott sent our application - including a cover letter, map and said petition - to the Board of Commissioners, Crow Wing County, and they will hold the required public hearing on Tuesday, November 9, 2004 at 11:00 A.M. at the courthouse in Brainerd. We would appreciate attendance and support at this meeting by all Round Lake property owners who are able to attend. Lake Edward Township approved the request for the district at their 10-12-04 meeting, and the City of Nisswa approved the request for the district at their 10-20-04 meeting.

In the cover letter, it was recommended that the new Round Lake Improvement district board be nine members, and that the Board of Commissioners name the current nine Round Lake Improvement Association board members to the first Round Lake Improvement district board of directors.

The district application was submitted in time to levy the assessment on the 2005 tax statements. Therefore, funds should be available next spring to apply against the Curly Leaf Pondweed control project.

If a Round Lake Improvement district is formed, we will likely rename our present association and continue it as an organization, covering things such as social events (picnic, Christmas party, regatta), speed control, road/property signing, lake-depth marking through Buoys, lake access control etc. It will no longer be charged with water-quality or lake-maintenance issues.

The Board MSP to appoint John Windh as the Round Lake Improvement District coordinator. John, with assistance from Scott Fisher, will monitor the improvement district approval process to ensure that we comply with all requirements.

If the membership has questions about the Round Lake Improvement District, there will be Round Lake Improvement Association Board members present at the Christmas party to answer any questions. Following are questions you may have at this time:

What was the process for forming this Round Lake Improvement District?

We presented a petition signed by a majority of Round Lake property owners to the county board asking them to form a Round Lake Improvement District. State law requires them to hold one or more public hearings and then vote on our request.

How is the improvement district board chosen?

State law says the county board appoints the first Round Lake Improvement District board, which must always be composed entirely of Round Lake property owners. We have asked that the new district board include nine members, three of whom are elected every year to three-year terms. We also suggested to the county board that they appoint the present Round Lake Improvement Association board members to the first Round Lake Improvement District board. Starting in 2005, Round Lake residents will elect new members to the district board every year.

Two very different names for the same organization

These names are so confusing!!

We seek to create a Round Lake Improvement District. Its name is mandated by state law. It would exist solely to deal with matters of water quality and aquatic management. Our present Round Lake Improvement Association would continue as a social voluntary organization. Since it will no longer be involved in lake improvement matters, its name should be changed. It would retain control of its present bank balance, and its board would be entirely separate from the board of the Round Lake Improvement District.




