Mississippi – Brainerd Planning Meeting Notes

1. Introductions: All online and in-person introductions were made.
2. Minutes:

▪ *Discussion Highlights:*

- Concerning Citizen Committee, Aitkin SWCD requested the addition of Barb Karls, Cedar Lake LID, Aitken and Dave Dickey, Aitkin, retired DNR to the Citizens Committee list.
- Dave Kircher provided the correct TWP for committee member Bruce Johnson (Todd County) as he felt Bruce represented Burnhamville TWP, not Grey Eagle TWP.
- Not all members of the Citizens Committee had been confirmed, so Policy Board decided to table approval of the Citizens Committee to a later meeting.

4. BWSR priorities and concerns for water resources:

Presenters: Chris Pence/Jeff Hrubes (BWSR)

- Questions and concerns about the planning process were collected from the group along with end goals. Answers were provided by BWSR.
- Melissa Barrick presented on the map package she provided.
- *Discussion Highlights:*

- The Brainerd- Mississippi is considered a *medium* sized watershed as compared to all HUC 8 watersheds, statewide..
- The history of the diversion channel in Aitkin was shared.
- Aitkin County has more miles of the Mississippi R. than any other state in the U.S.
- The watershed is unique due to the amount of city and stormwater considerations along with Ag land, shoreland, riparian areas, and forested lands.
- The plan allows neighboring LGUs, state agencies and citizens to get to know one another

5. Landscape Stewardship Plan Priorities:

Presenter: Lindberg Ekola (BWSR)

Discussion Highlights:

- Quality forests + Quality water = Quality life
- Land disturbance effects water quality. Research has shown that land disturbance in a particular water or lakeshed of 25% or more is the tipping point for negative impacts to water quality.
- Land disturbance can be amended resulting in positive impacts in a relatively short period. The projects and practices supported by Lessard-SAMS in Crow Wing County has reduced disturbed land area impacts in a period of 8 years.
- A question was posed, how can we increase forested areas when we are challenged with Oak Wilt, Emerald Ash Borer, and Buckthorn? Answer: Improved forest management will be the long term correction.
- There are approximately 100 certified private foresters, statewide.

- The plan process will be broken down into the following production chunks-
 - **Issue ID & Prioritization**
 - **Measurable Goals**
 - **Implementation Actions**
 - **Draft of Plan**
 - **Formal review**
 - **Final review**

8. Minnesota Department of Health priorities and concerns for groundwater:

Presenter: Chad Anderson, MDH

Discussion Highlights:

- There are 8,135 private wells with known locations in the watershed.
- Promotion Goals-
 - **Well sealing**
 - **Groundwater Education**
 - **More well testing**
 - **Promotion of Waste Collection**
 - **Nutrient Management**

- Though outside of the Brainerd Mississippi watershed, the City of St. Cloud is downstream. The source of the city's drinking water is the Mississippi R. Ammonia is the biggest concern for the city.
- Only .7% of the wells tested indicate high nitrates. It is important to note that not all wells have been tested, so any conclusions drawn at this point are considered somewhat "premature".
- Arsenic is another drinking water concern. Arsenic does occur naturally, but pollutants can increase the incidence of arsenic in water.
- A concern brought up by Jacob Frie was the fact that SWCD does receive results of testing and is tracking these results, however these results are not being received by the state of MN. Melissa and Chad will touch base on this topic to see if a change can be made.
- Tim Terrill from the Mississippi Headwaters Board presented a short video on the history of the Board, its purpose and intent for participation in the plan. Consider us as "salt"- adding a subtle hint of flavor, but not overpowering, he said.
