Attached, please find all the information requested in the Annual Checklist provided by Crow Wing County to the various lake improvement districts. If you have any questions or concerns, please do not hesitate to contact the undersigned officer of the Lake Ossawinnamakee Lake Improvement District.

The Lake Ossawinnamakee Lake Improvement District (“LOLID”) was formed for purposes of monitoring for aquatic invasive species and treating Lake Ossawinnamakee for these invasive species including, without limitation, Eurasian Watermilfoil and Curly-leaf Pondweed.

The LOLID held its annual meeting on June 21 2025. The published and written notices for the annual meeting are attached hereto for your reference as Attachment A. Also incorporated as a part of Attachment A is a copy of the 2025 Annual Meeting Agenda, the June 21, 2025 Minutes of Annual Meeting of LOLID, and the approved Budget for 2026.

The results of the election of the Board of Directors for the LOLID were reported at the Annual Meeting. The election information on the tabulation of ballots and evidence that election ballots were mailed out to all property owners at least three (3) weeks prior to the annual meeting are attached hereto as Attachment B.

The Board of Directors are Dave Peterson, Clif Giese, Rolf Rogers, Bob Noll and Bruce Palm. The election results are also incorporated in Attachment B.

The Board also discussed finances, including the financial report for 2025, which is attached hereto as Attachment C. The Board also approved a budget for 2026, which is included as a part of Attachment C. Please note that the 2025 Insurance Renewal is attached hereto as Attachment D.

With regard to future plans of the LOLID, it will continue to conduct multiple lake surveys and treatments when needed. The LOLID will continue treatment of Curly-leaf Pondweed. The LOLID has been working with the same treatment company, Central Minnesota Aquatics for over fifteen years. The LOLID, together with the Lake Ossawinnamakee Property Owners Association continues to make lake property owners aware of the threat of new aquatic invasive species posing a threat to the lake such as Starry Stonewort. Together with Central Minnesota Aquatics' inspections, property owners can and will act as another set of eyes looking for known threats. Lake Ossawinnamakee Property Owners Association volunteers also gather water samples, water temperature readings, weather data, and take Secchi Disk readings that are sent to RMB Laboratories for analysis and recording. Regarding the LID's interactions with other agencies, some LID Board members participated in educational seminars with MNCola, MAISRC, WAPOA and others. The Lake Ossawinnamakee Property Owners Association also continues to work with the DNR to stock Walleye fingerlings annually and contributes financially to this endeavor.



Meeting Called to Order: 10:00 am

Approval of June 15, 2024 Annual Meeting Minutes: Paul Zobitz made a motion to approve the minutes. Ron Ommen seconded the motion. Motion passed!


Election of Board of Directors: Ballots were tallied. Clif Giese and Rolf Rogers each received 72 votes. Bob Noll received 74 votes. Board has been approved.

Approval of 2026 Budget: Financial performance for 2024 was reviewed. The LID had a budget of \$77,300.89 in 2024. Expenses were \$77,101.42 resulting in a surplus of 198.58 for the year. Similarly, for the current 2025 budget year we expect to be on target at year end barring any unforeseen circumstances. The board is recommending no increase to the levy or budget for calendar year 2026. The LID will continue to control costs by taking on the mass mailings to lake residents and the annual report preparation instead of outsourcing these activities to our law firm. The board also acknowledged Ron Duy from Central MN Aquatics' efforts to hold the costs of his services in 2026 to 2024/2025 levels. Based on the recommendation of the Board, Rolf Rogers made a motion to approve the budget. Laurie Pierner seconded the motion. Motion passed!

Lake Review: Ron Duy from Central MN Aquatics reported we are now eleven years milfoil free. There has been no major increase in zebra mussels. Ron has treated 102 permitted areas for Curly Leaf Pondweed and has asked for our help in contacting three property owners he has not been able to reach. All three of these properties have curly leaf pondweed that needs to be remediated. We will try to make the contacts for him.

Other Business: Future AIS funding impacts – Governor Waltz has proposed cutting the AIS budget by 50%. This funding will be phased out by 2029. There are plans to increase the surcharge on three-year boat registrations and will increase AIS Control Grants. The Legislature set aside \$28 million for small local projects through the Environmental and Natural Resources Trust Fund. AIS is listed as a funding priority in this bill. Grants from this fund will be administered by the DNR.

RE: Summary of 2025 Central Minnesota Aquatics Lake Ossawinnamakee LID AIS Management Program

October 6, 2025

Central Minnesota Aquatics (CMA) sent a treatment authorization form in February 2025 to approximately 365 Lake Ossawinnamakee Lake Improvement District (LID) property owners as provided by Crow Wing County. Approximately 301 treatment authorization forms were completed by the property owners and returned to CMA, five (5) were "return to sender" as undeliverable. Approximately one hundred two (102) MN DNR permits were obtained to treat invasive plants "curly-leaf pondweed" around property owner docks. Each permit allows for two (2) treatments annually. There was approximately one hundred four (104) treatments performed and it is clearly again noted that curly-leaf pondweed easily becomes established in physically disturbed lake bottom areas. Currently, there are still no large areas of curly-leaf pondweed within Lake Ossawinnamakee and the LID has been able to successfully manage this invasive plant and its' negative impacts. Five (5) whole lake surveys were performed and no Eurasian watermilfoil was identified for the eleventh (11th) year in a row, no starry stonewort was identified either. Because Eurasian watermilfoil has not been identified within Lake Ossawinnamakee for over three years, the LID has achieved its eradication as defined by the MN DNR. All of the property owners that were spoken to during 2025 by CMA are fully supportive of the LID's program and they are very grateful for its success. The LID board is continuing to do a great job! Keep up the Good work!
