Amy,

The attached is the information requested by the annual checklist required for LIDS. I have included our annual report and minutes from our annual meeting that was held on August 30th, 2025. The purpose of the Sebie Lake Improvement District (SLID) is to improve the water quality of Sebie Lake through lake management of aquatic vegetation control and related services.

Our 2025 water quality initiatives focused on (1) water quality testing and (2) treatment of Curly Leaf Pondweed.

1. Water quality testing consisted of two locations, the main lake and the Nokasippi main inlet. Testing was 2 times during the summer period. This will be completed in October.
2. 15 acres were treated for Curly Leaf Pondweed in 2025. The goal for 2026 is to be able to again treat the maximum allowed 15 acres.

Actual treatment costs came in near our 2025 approved budget. Per our approved budget for 2026 if we treat at the maximum 15 acres our expenses will exceed our revenue. Should this continue for a number of years we will slowly burn down our reserves or we will need to reduce the acreage treated.

We did not engage in any studies or programs other than water quality testing and treatment of Curly Leaf Pondweed which included a plant survey of the treatment areas. The SLID does work with the Sebie Lake Area Conservation Association (SLACA) with similar goals in mind.

We appreciate the opportunity that Crow Wing County has given us in forming the SLID to improve the water quality and usability of Sebie Lake.

## SLID 2025- 7<sup>th</sup> Annual Meeting

Date: Saturday, August 30th, 2025 Time: 9:00 pm

Location: Fort Ripley City Hall

Board Members present: Mike Stacken, Tom Gustafson, Jerry Huntington, and Graham Gustafson

Call to Order: Mike Stacken called the meeting to order at 9:03.

Mike read the meeting minutes from the SLID 2<sup>nd</sup> quarter board meeting on the 6<sup>th</sup> of July, 2025. Tom made a motion to approve, Jerry 2nd, all were in favor of approval, Motion carried.

Financials: Tom provided the 2025 financial update. As of 30 August 2025, current balance of the Sebie Lake LID is \$16,363.74.

2026 Budget reviewed for the amount of \$10,700. When SLID began the total revenue was \$9,500. However, two property owners bought adjacent lots and only pay one assessment per SLID and county. The SLID revenue will be \$9,000 in 2026. The membership vote to approve the 2026 budget was approved unanimously.

Copies of the financials were available for membership review, and will also be submitted with the annual report.

Misc Expense- Motion by Tom and 2<sup>nd</sup> by Jerry to reimburse Mike Stacken for Postage in the amount of \$31.20. All board members were in favor. Motion carried.

Water Quality Testing: AW Research continues to test our water, and we have many prior year tests with a good history of the lake's health. Testing is getting more expensive and have reduced testing to twice a year. One water quality test has been conducted in 2025. One final test will be conducted later in the season.

Curly Leaf Pondweed Treatment: The chemical Flumioxazin was used instead of Aquathol-K to add variety to the chemical being used each year and Flumioxazin was slightly cheaper. Treatment costs are dependent on the number of acres allowed and the depth of the area being treated. Treatment by Tigris for 2025 was for the full 15 acres this year for a total of \$9,137.63. 2025 expenses were \$1,500 for Program Component fees including surveying, \$5,135.00 for Flumioxazin, and \$1,875.00 for application fee, \$627.63 tax. Matt Swanson and his partner have left Tigris and are formed their own company named Aqua Terra Solutions. Matt will provide a quote for services next spring. He will also be sending information to property for shoreline treatments.

**Annual Assessment:**

There was discussion around the annual \$250.00 that is assessed to each property owner for the LID. A motion was made by Tom and 2nd by Graham to maintain the \$250.00 assessment for 2026. All board members were in favor. Motion carried.

**Election of officers:**

Mike Stacken and Tom Gustafson positions on the board were up this year. Ballots were mailed to Sebie Lake members. 16 ballots were received but 2 ballots were not signed and no candidate selected. 14 ballots voted in favor of electing Mike Stacken and Tom Gustafson to the board.

**Open Discussion:**

- Members appreciate the SLID vs organizing tournaments and other events to raise funds.
- Treatment went well for curly leaf and positive feedback has been received from some members.
- This year's Annual meeting was moved to Labor Day for two reasons. First, the board can provide members a summarization of the year's activities and expenses and second, we have a requirement to file an annual report within 2 month of the meeting or by the 1<sup>st</sup> of November.

**2026 SLID Annual Meeting:** The Annual meeting date for the 2026 SLID Annual Meeting is set for the 5<sup>th</sup> of September, 0900 at Fort Ripley city hall. A motion was made by Jerry and 2nd by Tom. All board members were in favor. Motion carried.

Motion by Jerry to adjourn the meeting, 2nd by Graham. All in favor.


