

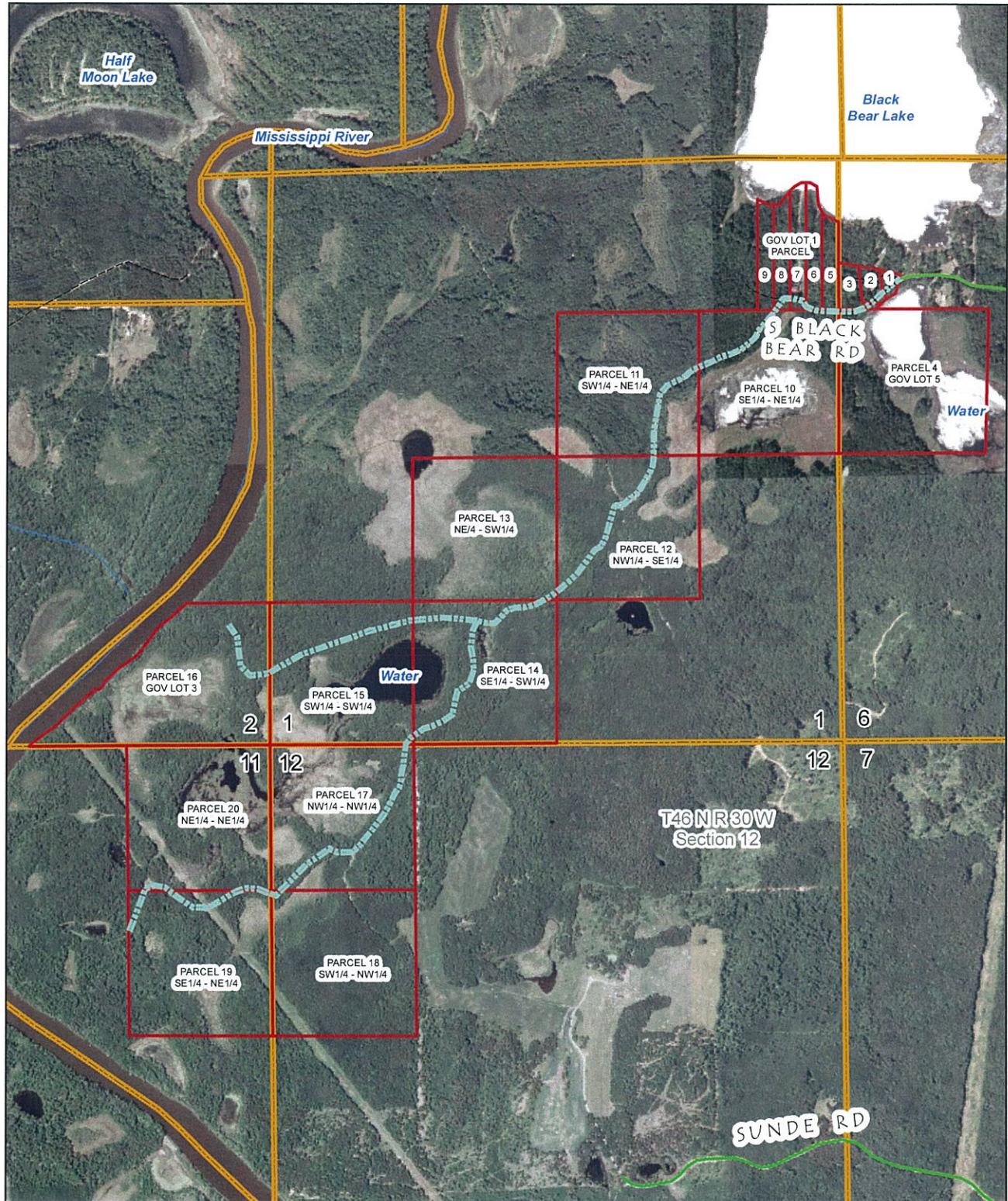

MS 89.715 states "the roads to be recorded will be to the width of the actual use including ditches, backslopes, fills, and maintained rights-of-ways". County Forest Roads are variable in width and the map symbol representing the County Forest Roads is intended to represent the location of those County Forest Roads, not the actual width.
